INTRODUCTION

1.1. INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation (“NRF”) as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF learning and teaching resources website (<https://www.nrf.ac.za>) for more information.

1.2. BACKGROUND TO SAASTA

The South African Agency for Science and Technology Advancement (NRF-SAASTA) is a business unit of the National Research Foundation. NRF-SAASTA’s mission is to promote broad public awareness, appreciation and understanding of science, engineering and technology in South Africa.

1.2.1. CONTEXT

The Educator Development Programme is designed to further develop educators to enhance their learning and teaching in the classroom. This is achieved through educator workshops and provision of learning and teaching resources. Therefore, educational resource materials such as a mini-PC device which can be used with any data-projector or digital screen including smart TVs is required for teaching of subjects like maths and science. The mini-PC should be loaded with interactive content materials for Mathematics and Physical Science which is CAPS aligned as will be shown on the specifications.

1.3. THE REQUIREMENTS OF THIS BID

The overall objective is to appoint a service provider who will provide 50 mini-PC devices which can be used with any data projector or digital screen including smart TVs. The service provider should also be able to train 50 educators on how to effectively use the resources.

2. PART A – BID REQUIREMENTS

2.1. EDUCATIONAL MATERIAL REQUIREMENT SPECIFICATIONS

The Educator Development Programme designed to further develop educators to enhance their learning and teaching in the classroom. This is achieved through educator workshops and provision of learning and teaching resources. Therefore, educational resources materials such as a mini-PC device which can be used with any data-projector or digital screen including smart TV’s is required for teaching of subjects like maths and science. The mini-PC should be loaded with interactive content materials for Mathematics and Physical Science that is CAPS aligned as will be shown on the specifications below. The delivery of goods will be at Didacta Building, 211 Nana Sita Street, Pretoria, 0001.

NRF-SAASTA would like to appoint a suitable service provider with the following:

- A minimum of 36 months in the supply of educational resource materials that are IT related;

- A minimum of 36 months of training educators in teaching maths and science using IT;
- Proof that the bidder has previously supplied large quantities of IT related educational resource materials. Three written reference letters that are not older than 36 months, in referee's letterheads are required; and
- Proof of financial capacity to successfully deliver or supply the educational materials.

Detailed specifications of the goods to be procured

1. Mini-PC device with Power Source, presentation accessories: Mouse, HDMI-VGA adapter, USB Speaker, multi plugs and leads (Quantity 50);
2. Software package (installed in the 50 Mini-PC's) that completely covers CAPS curriculum for Mathematics and Physical Sciences: Includes content lessons, Examination revision Lessons, CASIO calculator training videos, interactive self-assessment and feedback, digital textbook series and career guidance information. The Software package should also cover the following:
 - Animated CAPS maths and science PowerPoint lessons for the classroom – Grades 8 – 12;
 - Quality Mathematics textbooks with exercises and solutions by chapter – Grades 8-12;
 - Life Sciences text books and teacher guides; and
 - Past Provincial and National examination papers with memos in PDF format.
3. Provide 4-hour on-site training session and orientation for the 50 educators on how to use the mini-PC

2.2. DUE DILIGENCE

1. Detailed requirements to evaluate the bidder's ability to deliver on the bid. The bidder must provide the following:
 - 1.1. Business Profile:

A summarised business profile, relevant to the project, limited to a **maximum of 10 pages**. Relevant experience should clearly be stated.

The Business Profile must include, but is not limited to the following:

 - 1.1.1. Proof of location of business;
 - 1.1.2. Details of directors of the organisation;
 - 1.1.3. List of relevant services and products offered by the bidder;
 - 1.2. Contingency Plans:

Details of contingency planning relating to the project must be submitted, covering elements such as:

 - Labour unrest (strikes)
 - Transport (delivery of goods)
 - COVID-19 (Staff infections, disinfection of goods before delivery, staff protection, and etc.)

1.3. Costing Specifications:

Quotations must include the following, where applicable:

- 1.3.1. Value Added Tax (VAT);
- 1.3.2. Delivery charges to the stipulated delivery addresses;
- 1.3.3. Manuals and training on the usage of the resources; and
- 1.3.4. Project Management and Administration.

1.4. References:

Provide three relevant (procurement of educational resource materials) reference letters, on referee's letterheads, with contact details.

1.5. Ethical requirements

The bidder must confirm that there are no interests with the NRF and its business units, has clean business practises, and has determined its bid independently from others as reflected on its submitted SBD 1, SBD 4, SBD 6.1, SBD 8, and SBD 9 forms.

If the service provider fail to deliver within deadlines as specified under the service requirements, the service provider will be liable for any costs incurred by NRF-SAASTA to have the specific material supplied and distributed by any other third party.

General conditions of contract will be applicable to this bid.

All costs incurred for submission of the invitation to bid, is for the bidders account.

SAASTA reserves the right to:

- withdraw and cancel the bid.
- not to accept the lowest proposal

CONTRACT PERIOD

Twelve (12) months

CONTRACT MANAGEMENT

1 Method of delivery and conditions for determining successful delivery after contract (SBD 7) is signed

1.1 Packaging material used must be suitable for long distance courier to ensure materials are not damaged in transit.

1.2 Service provider must deliver to the specified delivery address

2 Delivery Timing

2.1 Service provider must provide samples for approval, prior to commencement of supply.

2.2 Service provider must deliver approved resource materials within 10 to 20 working days of receiving the approval from NRF-SAASTA as specified on the turnaround time.

2.3 48-hour notice must be given before deliveries are made. Working hours are between 08h00 and 16h00 during the week.

3 Supplier Relationship Management

3.1 Suppliers must avail themselves for meetings as and when they are requested by NRF-SAASTA

3.2 Service provider must not substitute any material other than stated on the specifications, unless discussed with NRF-SAASTA and written consent is given by NRF-SAASTA.

3.3 Service provider must respond to queries within 24 hours.

4 Warranty

36 Months warranty is required

5 Contract management during implementation

5.1. It is the Service provider's responsibility to collect, replace and/or fix any damaged, dysfunctional items supplied as per the warranty and guarantee in cases where the supplied items are not working properly.

5.2. The cost for the above stated will be incurred by the service provider.

6 Termination of contract due to non-performance

In the event of the non-performance as per the agreed contract, NRF-SAASTA will appoint an alternative at the cost of the appointed third party. The defaulting third party is obliged to settle the damages/additional costs that SAASTA has incurred as result of the non-performance of the appointed bidder.

7 Occupational Health and Safety when working on NRF sites:

7.1 All personnel performing work on NRF-SAASTA site/s as part of this contract are responsible to obtain safety induction.

7.2 Over and above the obligations provided by the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations, known as 'the Act'), the appointed bidder meets with all relevant health and safety instructions as given to them by site safety personnel, where relevant. Personal protection equipment including closed safety shoes, hard hats, height safety equipment, and high visibility vests are worn at all times while on the work site. All personnel are to obey the relevant instructions, including signage, related to restricted access and speed limits on all sites.

7.3 The appointed bidder, once signing the contract (SBD 7.1), is responsible for itself, its employees, and those people affected by its operations in terms of the Act the regulations promulgated in terms thereof. The appointed bidder performs all work and uses equipment on site complying with the provisions of the Act.

7.4 To this end, the appointed bidder shall make available to NRF-SAASTA on the valid Letter of Good Standing in terms of the COID Act and ensures its validity does not expire while executing this bid, where applicable. The appointed bidder furnishes its registration number with the office of the Compensation Commissioner.

7.5 The appointed bidder maintains a health and safety plan complying with the requirements of The Act at the work site during the period that contracted work takes place on the site.

7.6 NRF-SAASTA manages the appointed bidder in his capacity for the execution of this contract to meet the provisions of the said Act and the regulations promulgated in terms thereof. The appointed bidder accepts liability for any contraventions to the Act. Each member of the appointed bidder's team (including sub-contracted personnel), submit a signed indemnity form prior to entering the work site and kept in the appointed bidder's health and safety file.

8 Original bid documents for contract signing

The sets of original bid documents in hard copy format (paper document) serves as the original master set

for the legal contract document between the contracting parties. The master set remains at the NRF and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The master set has the originals or certified copies of any certificates stipulated in this document attached.

9 Managing service levels

- 9.1** Upon appointment, both parties agree on the final set of performance levels for each deliverable service levels including measurable key performance indicators with minimum thresholds in writing which is appended to this contract document.
- 9.2** Where both parties agree to variation of these, both parties sign the revision which is appended to this contract document.
- 9.3** The appointed third party and the NRF-SAASTA contract manager measure delivered performance against these performance levels.
- 9.4** Where either party has identified poor performance under this contract, both parties will meet and investigate the matter to determine the root cause, the correction plan, and the execution planning thereof.
- 9.5** Both parties will monitor the corrective actions.
- 9.6** Both parties will assess the applicability of penalties to the incurred poor performance and apply these,
- 9.7** The service performance levels are:

GENERAL AND SPECIAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC 1	Definitions - The following terms shall be interpreted as indicated:
1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
1.6	"Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
1.7	"Day" means calendar day.
1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	"Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12	"Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	"Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14	"GCC" mean the General Conditions of Contract.
1.15	"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16	"Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17	"Local content" means that portion of the bidding price, which is not included in the imported content if local manufacture does take place.
1.18	"Manufacture" means the production of products in a factory using labour, materials, components, and machinery and includes other related value-adding activities.
1.19	"Order" means an official written order issued for the supply of goods or works or the rendering of a service.
1.20	"Project site", where applicable, means the place indicated in bidding documents.
1.21	"Purchaser" means the organization purchasing the goods.
1.22	"Republic" means the Republic of South Africa.
1.23	"SCC" means the Special Conditions of Contract.

1.24	"Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
GCC2	Application
2.1	These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
2.2	Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
2.3	Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

GCC 4	Standards
4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
GCC 5	Use of contract documents and information
5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance.
