# **INTRODUCTION**

### **INTRODUCTION TO THE NRF**

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation ("NRF") as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (https://www.nrf.ac.za) for more information.

## **1.1. BACKGROUND TO SAASTA**

The South African Agency for Science and Technology Advancement (NRF-SAASTA) is a business unit of the National Research Foundation. Its mission is to promote broad public awareness, appreciation and understanding of science, engineering and technology in South Africa.

## **1.2.1. CONTEXT**

The National Science Olympiads are hosted by NRF-SAASTA on an annual basis. **Learners** from all schools, both primary and secondary, in all nine provinces are encouraged to enter and participate. They compete for provincial and national prizes in each of the Olympiads. There are four Science Olympiads, an Astronomy quiz as well as Science Debates for which these prizes are meant.

#### 2. Delivery Timing

- 2.1. Service provider must deliver the laptops and tablets within one month of contract signing.
- 2.2. 48-hour notice must be given before deliveries are made. Working hours are between 08h00 and 16h00 during the week.

### 2.2. DUE DILIGENCE

- 1. Detailed requirements to evaluate the bidder's ability to deliver on the bid. The bidder must provide the following:
  - 1.1. Business Profile:

A summarised business profile, relevant to the project, limited to a **maximum of 10 pages**. Relevant experience should clearly be stated.

The Business Profile must include, but is not limited to the following:

- 1.1.1. Proof of location of business;
- 1.1.2. Details of directors of the organisation;
- 1.1.3. List of relevant services and products offered by the bidder;
- 1.1.4. Proof of being in the business of a minimum of sixty (60) months of providing Laptops, and Tablets.
- 1.1.5. Proof of OEM certificate
- 1.1.6. Proof of gold status

### 1.2. Contingency Plans:

Details of contingency planning relating to the project must be submitted, covering elements such as:

- Labour unrest (strikes)
- Transport (delivery of goods)
- Securing of products within one month after signing of the contract. The agreements with the OEM
  must be submitted with the assurance of stock reservations if a successful bidder.

1.3. References:

Provide three <u>relevant</u> reference letters, on the referee's letterheads, with contact details, not older than sixty (60) months.

#### 3. Supplier Relationship Management

- 3.1. Suppliers must be able to avail themselves for meetings as and when they are requested by NRF-SAASTA
- 3.2. Service provider must respond to queries within 24 hours.

#### 4. Original bid documents for contract signing

4.1. The sets of original bid documents in hard copy format (paper document) serves as the original master set for the legal contract document between the contracting parties. The master set remains at the NRF and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The master set has the originals or certified copies of any certificates stipulated in this document attached.

#### 5. Managing service levels

- 5.1. Upon appointment, both parties agree on the final set of performance levels for each deliverable service levels including measurable key performance indicators with minimum thresholds in writing which is appended to this contract document.
- 5.2. Where both parties agree to variation of these, both parties sign the revision which is appended to this contract document.
- 5.3. The appointed third party and the NRF-SAASTA contract manager measure delivered performance against these performance levels.
- 5.4. Where either party has identified poor performance under this contract, both parties will meet and investigate the matter to determine the root cause, the correction plan, and the execution planning thereof.
- 5.5. Both parties will monitor the corrective actions.
- 5.6. Both parties will assess the applicability of penalties to the incurred poor performance and apply these,
- 5.7. The service performance levels are:

# **GENERAL AND SPECIAL CONDITIONS OF CONTRACT**

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC 1	Definitions - The following terms shall be interpreted as indicated:
1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
1.6	"Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
1.7	"Day" means calendar day.
1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	"Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin

	and which have the potential to harm the local industries in the RSA.
1.12	"Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	"Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detrimen of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14	"GCC" mean the General Conditions of Contract.
1.15	"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract
1.16	"Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are stil to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direc importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.

1.24	"Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
