# INTRODUCTION

## INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation ("NRF") as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (<https://www.nrf.ac.za>) for more information.

## BACKGROUND TO SAASTA

The South African Agency for Science and Technology Advancement (NRF-SAASTA) is a business unit of the National Research Foundation. NRF-SAASTA's mission is to promote broad public awareness, appreciation and understanding of science, engineering and technology in South Africa.

## THE REQUIREMENTS OF THIS BID

The overall objective is to appoint an agency to provide packers to pack questions papers, answer sheets and sort answer sheets after the event for NRF-SAASTA for a period of 36 months on an as-and-when required basis. In both instances monitors will be required. The contracted service provider will work in collaboration with the Science Education Division of NRF|SAASTA. Approximately 100 000 papers are written annually.

**Please note:** In view of technological advancement especially at schools, SAASTA is embarking on an online examination system going forward. This means that the need for packers and sorters will become less and less over the next three years, hence the as-and when-requirement basis.

# PART A – BID REQUIREMENTS

## SERVICES REQUIREMENT SPECIFICATIONS

### 1. Project Brief:

#### 1.1 Company profile

The Company profile of the envisaged agency must demonstrate the following capacity, capabilities and experience:

- In the business of recruiting and placing of temporary staff, especially packers, with a minimum of sixty (60) months experience
- Three (3) contactable references - from different companies/organisations/individuals not working for the same organisation - for whom you provided packers and monitors in the past sixty (60) months.

- The bidder must provide a company profile which should include the above mentioned items and proof thereof.

**Note: The above-mentioned should be highlighted in the company profile**

## **2.Packers**

The suitable service provider must have the capacity and capability to provide packing services by providing 40 packers and six (6) monitors at the same time for packing of Olympiads question papers and answer sheets for the National Science Olympiad. The final quantity of packers and monitors needed per annum, will be confirmed upon the subsidiary purchase order issued under this contract. Packers, sorters and monitors will be reporting to a project officer and a project coordinator. Due to the confidential nature of the information, it is compulsory for packers and monitors to practice confidentiality when handling the information. Controls required to practice confidentiality:

- The packers and monitors must sign a non-disclosure form with the agency.
- No documents to be removed from rooms where packing takes place, inclusive of any waste paper
- No cell phones allowed in packing rooms which will be on site at the NRF-SAASTA offices

NRF-SAASTA will expect accurate and meticulous workmanship to enable all schools to receive the correct number of papers per the specific Olympiad in the correct language.

### **2.1 For packing of question papers and answer sheets, the packers must be:**

- In possession of a grade 12 qualification
- Proficient in English
- Able to work under pressure
- Able to pay attention to detail including to count answer sheets and question papers accurately
- Able to pack question papers and answer sheets per subject, per school and per province
- Able to pack and label the envelopes correctly.

### **2.2 For sorting of answer sheets post competition the packers must be:**

- In possession of a grade 12 qualification
- Proficient in English
- Able to work under pressure
- Able to pay attention to detail including to count answer sheets accurately
- Able to open the envelope properly without damaging the answer sheets
- Able to sort original and photocopied answer sheets separately per subject, per school and per province

### 3.Monitors

Monitors are needed to monitor the packers during packing and sorting of the question papers and answer sheets.

**For monitoring of packers packing and sorting of the question papers and answer sheets, the monitors must:**

**Capability:**

- Have experience of minimum three (3) years in managing people. This should be reflected in the monitors' CVs.
- Be able to spot check, i.e. check packed envelopes and sorted answer sheets post competition
- Have Matric certificate or higher qualification
- One (1) year or more experience in monitoring of packers

#### 3.1Responsibilities:

Packers (40)	Monitors (6)

(List and envelopes to be provided by NRF-SAASTA)</li><li>• Double check the packed question papers and answer sheet before the envelope is sealed, pack and organise answer sheets per province per school per subject to ensure it is not lost.</li></ul>	<ul style="list-style-type: none"><li>• Monitor and spot check the number of question papers and answer sheets packed and/sorted are accurate and of required quality on a daily basis.</li><li>• Ensure the correct question papers and/or answer sheets are being packed or sorted as per the instruction from the project officer.</li><li>• Ensure no papers or part thereof leave packing rooms</li></ul>

#### 3.2 Work specification

- Ensure quality and accuracy of work done. This will be checked against feedback from schools once the papers have been delivered and written
- Be on-site full day
- Pay great attention to detail i.e. accuracy

## DUE DILIGENCE

1. The bidder must provide the following:
  - 1.1. Company Profile:

A summarised business profile, relevant to the project, limited to a maximum of 10 pages. Relevant experience in terms of handling confidential material should clearly be stated.

The company profile must include, but is not limited to the following:

    - 1.1.1. Provide transport method to deliver labour (packers/sorters) to SAASTA offices
    - 1.1.2. In the business of recruiting and placing of temporary staff with a minimum of sixty (60) months experience
    - 1.1.3. Indication of staff capacity, i.e. how many staff are currently available for this task on the bidder's books
2. Successful bidder undertakes not to share the questions papers/any related information with outside parties prior to the examination date as shall be determined by SAASTA
3. The successful bidder will be expected to submit short CVs, which highlight all the requirements, of all packers and monitors prior to the commencement of the job annually.
4. The successful bidder will also be expected to someone from management available in person to meet with the NRF-SAASTA team on site prior to the commencement of both the packing as well as the sorting job annually. He cost of travelling will be for the bidder's cost.

### Contingency Plans:

Service Provider to have a plan in place to deliver on the requirements. Penalties will apply if the appointed service provider cannot deliver the service.

- 4.1. Confidentiality:

The packers will be handling personal information and / or confidential examination answer sheets.
  - 4.2. Please indicate in your project plan what confidentiality measures will be put in place to ensure that there will be no leak of Olympiad papers, answer sheets and personal information.
5. References:

Three (3) contactable references with whom the bidder has done business by providing packers in the past sixty (60) months.

    - 5.1. Ethical requirements

The bidder must confirm that there are no interests with the NRF and its business units, has clean business practises, and has determined its bid independently from others as reflected on its submitted SBD 1, SBD 3.1, SBD 4 and SBD 6.1, forms.

## CONTRACT PERIOD

The contract is for a period of 36 months on an as-and-when required basis

## CONTRACT MANAGEMENT

1. Operating site

1.1 Packing and sorting of papers and answer sheets (post the event) will be done on SAASTA's premises (211 Nana Sita Street, Didacta Building, Pretoria)

**2. Lead times**

2.1 Must complete the packing of the Olympiad question papers, answer sheets and sorting of answer sheets (post competition), within 10 working days of receiving the approved order and the starting date from NRF-SAASTA.

2.2 Respond to queries within 24 hours.

**3. Contract conditions for supervising the scope of work**

1.1 Provide the number of staff and monitors as per the specific request per annum to be able to work in designated rooms at NRF-SAASTA.

1.2 Ensure that packers do not pack the Olympiad questions papers, answer sheets in such a way that it gets damaged in transit, i.e. papers are being couriered to schools.

1.3 Ensure that Olympiad questions papers and answer sheets are packed in quantities as per instructions from NRF-SAASTA.

1.3 In cases where there is a need for replacement of staff, the service provider must ensure that the staff have the same minimum qualification and experience

**4. Procurement of services during the contract**

4.1. SAASTA will provide the volume of work, the estimated required hours and staff quantities for the contracted service provider to provide an accurate quotation

**5. Supplier Relationship Management**

5.1. Meetings will be held with service provider as and when needed.

NRF-SAASTA reserves the right to:

- withdraw and cancel the bid.
- request the bidder to provide the rate per hour, rate for after hours, rate for weekend and/or holiday.
- request the bidder to provide CVs of the packers to ensure service requirements
- request **less** packers than the estimated number indicated in this document
- perform spot checks to ensure that prices are market related.

If the service provider fail to deliver within the deadlines as specified in service requirements specifications, the service provider will be liable for any costs incurred by NRF-SAASTA to complete the job by a third party.

**6. Replacement of non-performing staff**

NRF-SAASTA has the right to request the immediate replacement of any packer or monitor that does not meet service requirements or perform to the accepted standard

**7. Termination of contract due to non-performance**

7.1. In the event of the non-performance as per the agreed contract, NRF-SAASTA will appoint an

alternative at the cost of the appointed third party. The defaulting third party is obliged to settle the damages/additional costs that NRF-SAASTA has incurred as result of the non-performance of the appointed bidder.

8. Occupational Health and Safety when working on NRF sites:

- 8.1. All personnel performing work on NRF-SAASTA site/s as part of this contract are responsible to obtain safety induction.
- 8.2. Over and above the obligations provided by the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations, known as 'the Act'), the appointed bidder meets with all relevant health and safety instructions as given to them by site safety personnel, where relevant. Personal protection equipment including closed safety shoes, hard hats, height safety equipment, and high visibility vests are worn at all times while on the work site. All personnel are to obey the relevant instructions, including signage, related to restricted access and speed limits on all sites.
- 8.3. The appointed bidder, once signing the contract (**SBD 7 and the NRF's Section 37.2 agreement**), is responsible for itself, its employees, and those people affected by its operations in terms of the Act the regulations promulgated in terms thereof. The appointed bidder performs all work and uses equipment on site complying with the provisions of the Act.
- 8.4. To this end, the appointed bidder shall make available to NRF-SAASTA on the valid Letter of Good Standing in terms of the COID Act and ensures its validity does not expire while executing this bid, where applicable. The appointed bidder furnishes its registration number with the office of the Compensation Commissioner.
- 8.5. The appointed bidder maintains a health and safety plan complying with the requirements of The Act at the work site during the period that contracted work takes place on the site.
- 8.6. NRF-SAASTA manages the appointed bidder in his capacity for the execution of this contract to meet the provisions of the said Act and the regulations promulgated in terms thereof. The appointed bidder accepts liability for any contraventions to the Act. Each member of the appointed bidder's team (including sub-contracted personnel), submit a signed indemnity form prior to entering the work site and kept in the appointed bidder's health and safety file.

9. Original bid documents for contract signing

- 9.1. The sets of original bid documents in hard copy format (paper document) serves as the original master set for the legal contract document between the contracting parties. The master set remains at the NRF and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The master set has the originals or certified copies of any certificates stipulated in this document attached.

10. Managing service levels

- 10.1. Upon appointment, both parties agree on the final set of performance levels for each deliverable service levels including measurable key performance indicators with minimum thresholds in writing which is appended to this contract document.
- 10.2. Where both parties agree to variation of these, both parties sign the revision which is appended to this contract document.
- 10.3. The appointed third party and the SAASTA contract manager measure delivered performance against these performance levels.
- 10.4. Where either party has identified poor performance under this contract, both parties will meet and investigate the matter to determine the root cause, the correction plan, and the execution planning thereof.



- 10.5. Both parties will monitor the corrective actions.
- 10.6. Both parties will assess the applicability of penalties to the incurred poor performance and apply these,
- 10.7. The service performance levels are:

## GENERAL AND SPECIAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC 1	Definitions - The following terms shall be interpreted as indicated:
1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products

	internationally.
1.6	"Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
1.7	"Day" means calendar day.
1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
1.9	"Delivery ex stock" means immediate delivery directly from stock actually on hand.
1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	"Dumping" occurs when a private enterprise abroad markets its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12	"Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	"Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14	"GCC" mean the General Conditions of Contract.
1.15	"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16	"Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17	"Local content" means that portion of the bidding price, which is not included in the imported content if local manufacture does take place.

1.19	"Order" means an official written order issued for the supply of goods or works or the rendering of a service.
1.20	"Project site", where applicable, means the place indicated in bidding documents.
1.21	"Purchaser" means the organization purchasing the goods.
1.22	"Republic" means the Republic of South Africa.
1.23	"SCC" means the Special Conditions of Contract.
1.24	"Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person

5.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
5.4	The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

23.2	In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
23.3	Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
23.4	If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
