INTRODUCTION

INTRODUCTION TO THE NRF-SAASTA

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation (NRF) as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF-SAASTA website (<https://www.saasta.ac.za>) for more information.

BACKGROUND TO NRF-SAASTA

The South African Agency for Science and Technology Advancement (NRF-SAASTA) is a business unit of the National Research Foundation. NRF-SAASTA's mission is to promote broad public awareness, appreciation and understanding of science, engineering and technology in South Africa.

THE REQUIREMENTS OF THIS BID

The overall objective is to appoint an agency to provide packers to pack questions papers, answer sheets and sort answer sheets after the event for NRF-SAASTA for a period of 36 months on an as-and-when required basis. In both instances monitors will be required. The contracted service provider will work in collaboration with the Science Education Section of NRF-SAASTA.

CONTEXT: The NRF-SAASTA Olympiads forms part of the informal out-of-classroom science related activities. These Olympiads and competitions, amongst other, encourage learners to test their knowledge and build an interest in science subjects and related science fields. The National Science Olympiads are hosted annually by NRF-SAASTA. Learners from all schools, both primary and secondary across all nine provinces are encouraged to enter and take part. They compete for provincial and national prizes. Approximately 100 000 papers are written annually.

PLEASE NOTE: In view of technological advancement especially at schools, NRF-SAASTA is embarking on an online examination system going forward. This means that the need for packers and sorters will become less over the next three years, hence the as-and when-requirement basis.

PART A – BID REQUIREMENTS

SERVICES REQUIREMENT SPECIFICATIONS

1. Project Brief:

1.1. Company profile

The Company profile of the envisaged agency must demonstrate the following capacity, capabilities and experience:

- In the business of recruiting and placing of temporary staff, especially packers, with a minimum of sixty (60) months experience.
- Three (3) contactable references - from different companies/organisations/individuals not working for the same organisation - for whom you provided packers and monitors in the past sixty (60) months.

- The bidder must provide a company profile which should include the above-mentioned items and proof thereof.
- The bidder must submit a valid COIDA certificate (will be validated with the department of labour prior awarding)

Note: The above-mentioned should be **highlighted** in the company profile

2. Packers

The suitable service provider must have the capacity and capability to provide packing services by providing 40 packers and four (4) monitors at the same time for packing of Olympiads question papers and answer sheets for the National Science Olympiad. The final quantity of packers and monitors needed per annum, will be confirmed upon the subsidiary purchase order issued under this contract. Packers, sorters and monitors will be reporting to a professional officer and a liaison officer of the NRF-SAASTA. Due to the confidential nature of the information, it is compulsory for packers and monitors to practice confidentiality when handling the information. Controls required to practice confidentiality:

- The packers and monitors must sign a non-disclosure form with the agency.
- No documents to be removed from rooms where packing takes place, inclusive of any wastepaper
- No cell phones allowed in packing rooms which will be on site at the NRF-SAASTA offices

2.1 Packing of question papers and answer sheets, the packers must have the following:

- In possession of a Grade 12 qualification
- Proficient in English
- Able to work under pressure
- Able to pay attention to detail including to count answer sheets and question papers accurately
- Able to pack question papers and answer sheets per subject, per school and per province
- Able to pack and label the envelopes correctly.

2.2 Sorting of answer sheets post competition, the packers must have the following:

- In possession of a Grade 12 qualification
- Proficient in English
- Able to work under pressure
- Able to pay attention to detail including to sort answer sheets numerically
- Able to open the envelope properly without damaging the answer sheets
- Able to sort original and photocopied answer sheets separately per subject, per school and per province

3. Monitoring of the packers and sorters

Monitors are required to supervise the packers during the packing and sorting of question papers and answer sheets.

Capability: Supervision of packers and sorters of question papers and answer sheets. The monitors must meet the following criteria:

- A minimum of three (3) years' experience in supervising staff, as evidenced in the monitors' CVs.
- Ability to conduct spot checks, including inspecting packed envelopes and sorted answer sheets after the competition.
- A Grade 12 certificate or a higher qualification.

3.1. At least one (1) year of experience in monitoring packers.

3.2. Responsibilities of packers and monitors:

• Correctly pack question papers and answer sheets as per the list into the relevant envelope. (List and envelopes to be provided by NRF-SAASTA) • Double check the packed question papers and answer sheet before the envelope is sealed, pack and organise answer sheets per province per school per subject to ensure no school is omitted.	• Monitor and spot-check daily that the number of question papers and answer sheets packed and/or sorted is accurate and meets the required quality standards. • Ensure that the correct question papers and/or answer sheets are packed or sorted in accordance with instructions from the professional officer. • Ensure that no papers, or any part thereof, leave the packing rooms, are copied, or photographed.

3.3. Expected reporting of packers and sorters

- Ensure quality and accuracy of work done. This will be checked against feedback from schools once the papers have been delivered and written
- Be on-site full day
- Pay great attention to detail i.e. accuracy

DUE DILIGENCE

The bidder must provide the following:

○ Company Profile:

A summarised business profile, relevant to the project, limited to a maximum of 10 pages.

Relevant experience in terms of handling confidential material should clearly be stated.

The company profile must include, but is not limited to the following:

- Provide transport method to deliver labour (packers/sorters) to NRF-SAASTA offices
- Evidence that the bidder has a minimum of sixty (60) months experience in the recruiting and placing of temporary staff.
- Indication of staff capacity (Packers, sorters and monitors). The bidder must indicate how many packers/sorters and monitors they have on their books, or the bidder must describe the projects/clients where the bidder had provided resources of a similar or bigger magnitude.
- Proof of location (utility bill or lease agreement)

- Project Plans: Please specify in your project plan the confidentiality measures that will be implemented to prevent any leakage of Olympiad papers, answer sheets, or personal information
 - Contingency Plans: The service provider must have a contingency plan in place to ensure delivery of the required services. Penalties will be imposed if the appointed service provider fails to deliver.
 - References: Three (3) contactable reference letters with whom the bidder has done business by providing temporary staff, preferably packers and/or sorters and monitors in the past sixty (60) months must be provided.
 - Ethical Requirements - The bidder must confirm that there are no interests with the NRF-SAASTA and its business units, has clean business practises, and has determined its bid independently from others as reflected on its submitted SBD 1, SBD 3.1, SBD 4 and SBD 6.1, forms
- The successful bidder undertakes not to disclose the question papers or any related information to any external parties before the examination date as determined by NRF-SAASTA
 - The successful bidder will be expected to submit short CVs, which highlight all the requirements, of all packers and monitors prior to the commencement of the job annually.
 - The successful bidder will be expected to have a representative from management available in person to meet with the NRF-SAASTA team on site prior to the commencement of both the packing and sorting activities each year. Travel costs will be borne by the bidder.

CONTRACT PERIOD

The contract is for a period of 36 months on an as-and-when required basis

CONTRACT MANAGEMENT

○ **Operating site**

Packing and sorting of question papers and answer sheets (prior and post the event) will be done on NRF-SAASTA's premises at 211, Nana Sita Street, Didacta Building, Pretoria.

○ **Lead times**

- Must complete the packing of the Olympiad question papers and answer sheets (prior to competition), within 10 working days of receiving the approved order and the starting date from NRF-SAASTA
- Must complete the sorting of the Olympiad answer sheets (post competition), within 10 working days of receiving the approved order and the starting date from NRF-SAASTA
- Respond to queries within 24 hours

○ **Contract conditions for supervising the scope of work**

- Provide the number of staff and monitors as per the specific request per annum to be able to work in designated rooms at NRF-SAASTA
- Ensure that packers do not pack the Olympiad questions papers, answer sheets in such a way that it gets damaged in transit, i.e. papers are being couriered to schools
- Ensure that Olympiads questions papers and answer sheets are packed in quantities as per instructions from NRF-SAASTA

- In cases where there is a need for replacement of staff, the service provider must ensure that the staff have the same minimum qualification and experience, i.e. provide NRF-SAASTA with the relevant CV.
- NRF-SAASTA will expect accurate and meticulous workmanship to enable all schools to receive the correct number of papers per the specific Olympiad in the correct language

- **Procurement of services during the contract**

NRF-SAASTA will provide the volume of work, the estimated required hours and staff quantities for the contracted service provider to provide an accurate quotation

- **Supplier Relationship Management**

- Meetings will be held with service provider as and when needed.

NRF-SAASTA reserves the right to:

- withdraw and cancel the bid.
- request the bidder to provide the rate per hour, rate for after hours, rate for weekend and/or holiday.
- request the bidder to provide CVs of the packers to ensure service requirements
- request **less** packers than the estimated number indicated in this document
- perform spot checks to ensure that prices are market related.

If the service provider fails to deliver within the deadlines as specified in service requirements specifications, the service provider will be liable for any costs incurred by NRF-SAASTA to complete the job by a third party.

- **Replacement of non-performing staff**

NRF-SAASTA has the right to request the immediate replacement of any packer, sorter or monitor that does not meet service requirements, perform to the accepted standard or misbehave in any way.

- **Termination of contract due to non-performance**

- In the event of the non-performance as per the agreed contract, NRF-SAASTA will appoint an alternative at the cost of the appointed third party. The defaulting third party is obliged to settle the damages/additional costs that NRF-SAASTA has incurred as result of the non-performance of the appointed bidder.

- **Occupational Health and Safety when working on NRF-SAASTA sites:**

- All personnel performing work on NRF-SAASTA site/s as part of this contract are responsible to obtain safety induction.
- Over and above the obligations provided by the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations, known as 'the Act'), the appointed bidder meets with all relevant health and safety instructions as given to them by site safety personnel, where relevant. Personal protection equipment including closed safety shoes, hard hats, height safety equipment, and high visibility vests are worn at all times while on the work site. All personnel are to obey the relevant instructions, including signage, related to restricted access and speed limits on all sites.
- The appointed bidder, once signing the contract (**SBD 7**), is responsible for itself, its employees, and those people affected by its operations in terms of the Act the regulations promulgated in terms thereof. The appointed bidder performs all work and uses equipment on site complying with the provisions of the Act.
- To this end, the appointed bidder shall make available to NRF-SAASTA on the valid Letter of Good Standing in terms of the COID Act and ensures its validity does not expire while executing this bid, where applicable. The appointed bidder furnishes its registration number with the office of the

Compensation Commissioner.

- The appointed bidder maintains a health and safety plan complying with the requirements of The Act at the work site during the period that contracted work takes place on the site.
- NRF-SAASTA manages the appointed bidder in his capacity for the execution of this contract to meet the provisions of the said Act and the regulations promulgated in terms thereof. The appointed bidder accepts liability for any contraventions to the Act. Each member of the appointed bidder's team (including sub-contracted personnel), submit a signed indemnity form prior to entering the work site and kept in the appointed bidder's health and safety file.

○ **Original bid documents for contract signing**

The set of electronic original bid document format (electronic document) serves as the original master set for the legal contract document between the contracting parties. The master set remains at the NRF-SAASTA and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The master set has the originals or certified copies of any certificates stipulated in this document attached.

○ **Managing service levels**

- Upon appointment, both parties agree on the final set of performance levels for each deliverable service levels including measurable key performance indicators with minimum thresholds in writing which is appended to this contract document.
- Where both parties agree to variation of these, both parties sign the revision which is appended to this contract document.
- The appointed third party and the NRF-SAASTA contract manager measure delivered performance against these performance levels.
- Where either party has identified poor performance under this contract, both parties will meet and investigate the matter to determine the root cause, the correction plan, and the execution planning thereof.
- Both parties will monitor the corrective actions.
- Both parties will assess the applicability of penalties to the incurred poor performance and apply these,
- The service performance levels are:

GENERAL AND SPECIAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC 1	Definitions - The following terms shall be interpreted as indicated:
1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
1.6	"Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
1.7	"Day" means calendar day.
1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
1.9	"Delivery ex stock" means immediate delivery directly from stock on hand.
1.10	"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
1.11	"Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12	"Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13	"Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14	"GCC" mean the General Conditions of Contract.
1.15	"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16	"Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17	"Local content" means that portion of the bidding price, which is not included in the imported content if local manufacture does take place.

1.18	"Manufacture" means the production of products in a factory using labour, materials, components, and machinery and includes other related value-adding activities.
1.19	"Order" means an official written order issued for the supply of goods or works or the rendering of a service.
1.20	"Project site", where applicable, means the place indicated in bidding documents.
1.21	"Purchaser" means the organization purchasing the goods.
1.22	"Republic" means the Republic of South Africa.
1.23	"SCC" means the Special Conditions of Contract.
1.24	"Services" means those functional services ancillaries to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
1.25	"Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.
GCC2	Application
2.1	These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
2.2	Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
2.3	Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3.1	Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
3.2	With certain exceptions (National Treasury's eTender website), invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za
GCC 4	Standards
4.1	The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
GCC 5	Use of contract documents and information
5.1	The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance.
5.2	The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
5.3	Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
5.4	The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
SCC5A	Copyright and Intellectual Property

Both parties disclose openly such intellectual property ownership to the parties in writing at the commencement of this contract. The contracted party grants the NRF-SAASTA a fully paid up, irrevocable, and non-exclusive licence to use its background intellectual property for the exploitation of this contract to enable the NRF-SAASTA to obtain the full benefit of the contracted deliverables for this contract. The parties agree that all right, title, and interest in contract intellectual property created during the execution of this contract invests with the NRF-SAASTA unless where agreed in writing to a different allocation of the ownership of the contract intellectual property with such allocation being an addendum to this contract. Both parties to this contract shall keep the intellectual property created during this contract confidential and shall fulfil its confidentiality obligations

	as set out in this document. The contracted party agrees to assist the NRF-SAASTA in obtaining statutory protection for the contract intellectual property at the expense of the NRF-SAASTA wherever the NRF-SAASTA may choose to obtain such statutory protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of its respective contract intellectual property to the NRF-SAASTA or as the NRF-SAASTA may direct, and to support the NRF-SAASTA or its nominee, in the prosecution and enforcement thereof in any country in the world. The contracted party irrevocably appoints the NRF-SAASTA to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that the NRF-SAASTA, in its discretion, requires to give effect to the terms of this clause.
SCC5B	Confidentiality
	The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with the NRF-SAASTA and after termination of its involvement with the NRF-SAASTA, the recipient shall not: • Disclose the confidential information, directly or indirectly, to any person or entity, without the NRF-SAASTA's prior written consent. • Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or • Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract. The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to • Disclose the confidential information to any third party, or • Use the confidential information otherwise than as may be strictly necessary for the execution of the contract, • The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party. The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein. Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract. The recipient acknowledges that the unauthorised disclosure of confidential information may cause harm to the NRF-SAASTA. The recipient agrees that, in the event of a breach or threatened breach of confidentiality, the NRF-SAASTA is entitled to seek injunctive relief or specific performance, in order to obtain immediate remedies. Any such remedy shall be in addition to and not in lieu of any other remedies available at law, including monetary damages.

23.2	In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
23.3	Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
23.4	If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of

4. POINTS AWARDED FOR SPECIFIC GOALS

 - (c) cancel the contract and claim any damages which it has suffered because of having to make less favourable arrangements due to such cancellation.
